



# Angelina County Appraisal District

**EXEMPTION DATA:** The entities have various exemptions for which taxpayers may qualify; such as Homestead, Over-65, and Disabled Person residential exemptions. You may apply for a residence exemption on only one property in a tax year. A homestead may include up to 20 acres of land actually used in the residential use/occupancy of your home. To qualify for a homestead exemption, you must own and reside in your home on January 1<sup>st</sup>. You may file a late homestead exemption if you file it no later than one year after the date that taxes become delinquent. There is also a Transfer of Tax Limitation or Ceiling Certificate if you move out of the county; this can transfer to the new county in which you reside.
